Teaser	If you want to work as a researcher in Germany, you can obtain a residence permit for the purpose of research.
Volltext	<p>You can obtain a residence permit for the purpose of research if you have concluded a hosting agreement or a corresponding contract with a research institution in Germany to carry out a research project.</p> <p>With a German residence permit for research purposes, you can also conduct research and teach in another EU state for a limited period of time. Some member states require a separate notification to the respective competent authorities for this purpose. You can find information about the procedure and contact details of the respective National Contact Points in other EU member states on the homepage of the Federal Office for Migration and Refugees (see "Further information").</p> <p>The residence permit for the purpose of research is a temporary residence title. It is issued for at least one year, and for at least 2 years in case of participation in a Union or multilateral program with mobility</p>

measures. In case of a shorter duration of the research project, it is issued for its duration, but in case of participation in a Union or multilateral program with mobility measures for at least one year.

The residence permit entitles the holder to take up research activities at the research institution designated in the hosting agreement and to take up teaching activities. The changes of the research project during the stay do not lead to the lapse of this authorization.

Erforderliche Unterlagen

- \- Valid passport or passport replacement
- \- Visa, if required
- \- Current biometric photo
- \- Hosting agreement or a corresponding contract with a research institution
- \- Proof of living expenses (e.g. proof of income)
- \- Proof of health insurance
- \- rental contract

Voraussetzungen

- \- You have a recognized and valid passport or passport replacement and, if required, an appropriate visa.
 - \- There is no interest in deportation against you.
 - \- Your stay does not endanger or impair the interests of the Federal Republic of Germany.
 - \- You have concluded a hosting agreement or a corresponding contract with a research institution to carry out a research project in Germany.
 - \- A declaration of acceptance of costs by the research institution is available.
- In principle, the research institution must undertake in writing to assume costs incurred by public bodies up to six months after termination of the hosting agreement or contract. These include the costs of subsistence during an unauthorized stay in an EU member state and for deportation.
- However, a declaration of assumption of costs is not required in certain cases. Please contact your responsible foreigners authority in this regard.
- \- You can secure your livelihood and health insurance coverage from your income without claiming public benefits.

Kosten	<ul style="list-style-type: none"> • Issue of residence permit for the purpose of research: EUR 100. • Under certain conditions, a fee reduction or fee exemption may be considered.
Verfahrensablauf	<p>The residence permit must be applied for at the foreigners authority responsible for your place of residence. The procedure is as follows:</p> <p>\- Depending on the foreigners authority and your request, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic application for the residence permit.</p> <p>\- If the application is only possible in person, make an appointment with the Aliens' Registration Office. During the appointment, your application will be received and your supporting documents will be checked (bring them with you to the appointment). For the production of an electronic residence permit (eAT card) your fingerprints will be taken.</p> <p>\- In the case of an electronic application, the Aliens' Registration Office will contact you after receiving your online application to arrange an appointment at the Aliens' Registration Office, if necessary. During the appointment, your supporting documents will be checked (bring them with you to the appointment) and your fingerprints will be taken for the production of the electronic residence permit (eAT- card).</p> <p>\- If your application is approved, the Aliens' Registration Office will arrange for the eAT card to be produced.</p> <p>\- After about six to eight weeks, you can collect the eAT card from the Aliens' Registration Office.</p> <p>\- The eAT card must always be collected in person.</p> <p>Fees are charged for the issuance of the residence permit. The timing and form of payment varies depending on the authority.</p>

Kurztext	<p>\\- Residence Permit for the Purpose of Gainful Employment, Issued for the Purpose of Research</p> <p>\\- Foreigners who wish to carry out a research project in Germany and have concluded a hosting agreement or a corresponding contract with a research institution in Germany for this purpose can obtain a residence permit for the purpose of research.</p> <p>\\- The residence permit entitles the holder to take up research activities at a research institution designated in the hosting agreement and to take up teaching activities.</p> <p>\\- In accordance with the requirements of Directive (EU) 2016/801, the residence permit pursuant to Section 18d (1) Residence Act entitles the holder to short-term and long-term mobility to another EU Member State.</p> <p>\\- The residence permit is issued for at least one year, in case of participation in a Union or multilateral program with mobility measures for at least two years. In case of a shorter duration of the research project, the residence permit is issued for its duration, but in case of participation in a Union or multilateral program with mobility measures for at least one year.</p> <p>\\- Holders of a residence permit for the purpose of research may obtain a settlement permit after fulfilling certain requirements.</p> <p>\\- Spouses of holders of a residence permit for the purpose of research are also entitled to a residence</p>
