Teaser	If your vehicle/vehicle combination/transport deviates from the regulations of the StVZO and therefore cannot be approved, you can obtain an exemption under certain conditions.
Volltext	Transports that do not comply with the construction and operating regulations of the Road Traffic Licensing Regulations (StVZO) require a special permit in accordance with § 70 Para. 1 StVZO in order to participate in public road traffic. Exemption permits for heavy goods and goods traffic in accordance with Section 70 StVZO and the permit in accordance with Section 29 StVO are always required together in the above-mentioned cases. If one of the permits is not available, the other is also invalid.

Sachverhalt

In principle, exceptions may only be approved if all reasonable possibilities for complying with the provisions of the StVZO have been fully exhausted.

They may only be approved to the extent that is absolutely necessary for the intended purpose (strict standard); no exemption may be granted for economic reasons alone.

An exemption may be considered if the vehicle/vehicle combination itself is too long/too wide/too high - see § 32 StVZO - protruding load (e.g. by widening and/or extending the loading area) and/or

if higher axle loads and/or total weights than legally permitted - see § 34 StVZO - are to be used and/or

if the driver's field of vision is impaired - see § 35 b StVZO.

The exemption permits must be obtained by the vehicle owner, carried along when driving and handed over to the responsible persons for inspection on request.

The exemption permit is usually limited to three months.

Details of the route and type of vehicle (length, width, load, axle loads)

If applicable, declaration that transportation by rail and/or water is out of the question and, if applicable, proof of this

Declaration of liability, if applicable

Certificate of insurance, if applicable (see Appendix 8)

Authorization, if the application is submitted for a third party

	provisions of the StVZO and the FZV have been fully exhausted.
Kosten	Fees apply. Amount of costs (variable): from 10.20 to 511.00 euros. Legal basis: No. 255 Annex 1 to § 1 GebOSt. Note: The amount of the fees is based on the scale of fees for road traffic measures (GebOSt). There, a framework fee of €10.20 to €511.00 is set for each decision on an exemption from a provision of the StVZO per exemption and per vehicle/person; if there are several vehicles of the same design when the application is submitted, a reduced fee may be set. The exact amount of the fee depends on the processing effort, duration of validity and economic advantage for the applicant in each individual case; the determination is at the discretion of the authority.
Verfahrensablauf	You can submit your application online or in writing. Note: The application procedure for the permit also required in accordance with Sections 29 (3), 46 (1) No. 2, 5 StVO is fully digitalized via the VEMAGS portal. The competent authority will check your application, request additional documents if necessary and, in particular, carry out the hearing procedure with the authorities involved. If your application is approved, it will issue the exemption permit and charge the fees.
