Kurztext	• Fishing tax payment • Anyone wishing to fish or angling in Thuringia must pay a fishing tax. This can be paid on site (at the competent authority). • The fishing tax must be paid before the fishing license is issued. • Prerequisites: Minimum age 14, except youth fishing license: minimum age 8 years • Fees apply. • Responsible: For persons residing in Thuringia: the municipal administration responsible for the place of residence. For persons residing outside Thuringia: the local authority in whose jurisdiction fishing with a hand-held fishing rod is to be practiced.
