Teaser	As a skilled worker with an academic qualification, you can obtain a residence permit to look for a job for a period of six months if you meet certain requirements.
Volltext	You can obtain a residence permit to look for a job for skilled workers if you have a university degree. If you do not have a German university degree, your degree must either be recognized or be comparable to a German university degree. You can apply for recognition or assessment of comparability before you enter Germany (see further information).
	If you are already in Germany, you can obtain a residence permit to look for a job if you were previously in possession of a residence permit for gainful employment or a residence permit for the purpose of an EU study-related internship.
	If you wish to work in a regulated profession, the required professional license must already have been granted or approved when the residence permit for job-seeking purposes is issued.
	Regulated professions are professional activities that are subject to the possession of certain professional qualifications by law or administrative regulations.

	Professions regulated in Germany are, for example, doctor, nurse, lawyer, teacher, educator or engineer.
	With a residence permit to look for a job, you can take up a trial job for up to ten hours per week if you have the qualifications to do so.
	The residence permit is issued for up to six months.

	In individual cases, the Immigration Office may request further documents

You possess a German, a recognized foreign or a foreign university degree comparable to a German university degree The subject of your job search is employment as a specialist. If necessary, you have a license to practice your

	 Additional fees may apply for the issuance of a residence permit in the form of an electronic residence permit, which can also be used as electronic proof of identity. The time and form of fee collection and payment vary depending on the authority. Under certain circumstances, a fee reduction or fee exemption may be possible.
Verfahrensablauf	The procedure is as follows:
	 Depending on the foreigners authority and your request, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic application for a residence permit. If you can only apply in person, make an appointment with the immigration office. During the appointment, your application will be accepted and your supporting documents will be checked (bring these with you to the appointment). Your fingerprints will be taken for the production of an electronic residence permit (eAT card). In the case of an electronic application, the Immigration Office will contact you after receiving your online application to arrange an appointment at the Immigration Office if necessary. During the appointment, your documents will be checked (bring them with you to the appointment) and your fingerprints will be taken for the production of the electronic residence permit (eAT card). If your application is approved, the Foreigners' Registration Office will arrange for the eAT card to be issued. After about six to eight weeks, you can collect the eAT card from the immigration office. The eAT card must always be collected in person.

Rechtsbehelf	The decision of the immigration authority can be appealed to the court named in the decision.
Kurztext	 Residence permit for the purpose of gainful employment Issued to qualified specialists with an academic education to look for a job Foreigners who hold a German, a recognized foreign or a foreign university degree that is comparable to a German one can obtain a residence permit for the purpose of seeking employment. Foreign skilled workers who are already in Germany can obtain a residence permit to look for a job if they were in possession of a residence permit for gainful employment or a residence permit for the purpose of an EU study-related internship immediately beforehand. The residence permit entitles the holder to carry out a trial employment for up to ten hours per week for which they are qualified. The residence permit is issued for up to six months. Depending on the foreigners authority and your request, you can apply online or in person. A fee is charged for the issue of the residence permit.
