Teaser	If you have successfully completed your studies in Germany, you can apply for a residence permit for up to 18 months to find a job that matches your qualifications.
Volltext	As a foreign graduate of a German university, you can apply for a residence permit to look for a job following your studies. The employment you are seeking must be one for which you are qualified on the basis of your qualifications. The desired gainful employment can also be self-employment. This residence permit can be issued for up to 18 months. The residence permit only serves the one-time purpose of seeking employment and cannot be

	extended beyond this maximum period.
	During the job search, any gainful employment is permitted and does not require a permit.
Erforderliche Unterlagen	 Recognized and valid identity document (for example, passport or passport substitute). Visa, if it was required for entry into the country Current biometric photo in passport format (45 x 35 mm) Valid residence permit for the purpose of studies (§ 16b or § 16c of the Residence Act) Proof of successful completion of studies in Germany Proof of livelihood (e.g. employment contract, equity, blocked account, declaration of commitment) Proof of health insurance coverage Current certificate of registration

Voraussetzungen	 You have a recognized and valid identity document (for example, passport or passport substitute). You have a valid residence permit for the purpose of studying (§ 16b or § 16c of the Residence Act). You have successfully completed your studies in Germany and the period of validity of your residence permit will expire in the near future. You can secure your livelihood and health insurance coverage without claiming public benefits. There is no interest in deportation against you. Your stay does not endanger or impair the interests of the Federal Republic of Germany.

	The time and the form of the fee collection as well as the payment vary depending on the authority.
Verfahrensablauf	 Find out whether your foreigners authority allows you to apply online or has a special application form. If the application can only be submitted in person, make an appointment at the Aliens' Registration Office. In the case of online application, the Aliens' Registration Office will contact you after receiving your application to schedule an appointment. During the appointment, your identity and documents will be checked (please bring your documents to the appointment, if possible in original). If your application is granted, your fingerprints will be taken for the production of a new electronic residence permit (eAT card). The Aliens' Registration Office will order the production of the eAT card from the Bundesdruckerei. After completion, you will receive information and can pick up the residence permit at the responsible office. The eAT card must always be collected in person. If your application is rejected, you will receive a rejection notice.
Bearbeitungsdauer	It takes about 4 to 6 weeks for the Bundesdruckerei to produce the electronic residence permit.
Frist	• The residence permit should be applied for at least eight weeks before your visa or current residence permit expires. • The residence permit is issued for a maximum of 18 months. • Time limit for action: one month

Kurztext	 Residence Permit for the Purpose of Gainful Employment Issuance for Job Search after Completion of Studies Foreign graduates of German universities can obtain a residence permit for the purpose of seeking employment after completing their studies Prior possession of a residence permit for the purpose of studying (§ 16b or § 16c Residence Act) is required. The employment sought must be related to the qualification acquired during studies. The establishment of self-employment is also possible. Residence permits are issued for up to 18 months and cannot be extended. Any gainful employment is permitted during the job search. Responsible: the foreigners authority responsible for the applicant's place of residence.
