Teaser	If you wish to work temporarily as a foreign financial investment broker and advisor in Germany, you must notify the competent authority.
Volltext	As a financial investment broker and advisor, you require a license in Germany. If you only wish to work as a self-employed financial investment broker on a temporary basis, prior written notification to the competent authority is sufficient. However, this only applies to EU or EEA citizens.

Verfahrensablauf	The granting of the license is automatically entered in the register of intermediaries. After you have received the permit, you must register your business before you start your activity.
