Teaser	If you run a business or work as a freelancer, you can apply for a parking permit. This allows you to park in certain areas for the duration of your work assignment.
Volltext	Vehicles belonging to a business or self-employed person can receive a parking permit from the competent authority. This can, for example, entitle the holder to park free of charge in restricted no-parking zones, resident parking zones or parking management zones (parking spaces with parking meters or parking ticket machines). The exemption permit is generally only valid for certain individual activities of the business or freelancer. Please note the exact content of the exemption permit. Above all, when using the exemption permit, other persons must not be endangered or hindered.
Erforderliche Unterlagen	The documents to be submitted vary from authority to authority. For example, you must submit a copy of the business registration and a copy of the vehicle registration document.
Voraussetzungen	The competent authority shall examine the application for the parking permit. There is no entitlement of the applicant person.

	The amount of the fee varies depending on the number of vehicles, the period of validity of the parking permit and its scope.
Verfahrensablauf	You must submit an application for the granting of the exemption. How to make the application varies from authority to authority. The authority then examines your application and, if necessary, issues the exemption.
