| Teaser | You can extend your residence permit for the purpose of research before it expires if you wish to continue your work as a researcher in Germany. |
| Volltext | The residence permit for the purpose of research is a temporary residence permit. You can apply for an extension of the residence permit for the purpose of research if your work at a German research institution is to be continued beyond the period of validity of your residence permit. Apply for the extension of your residence permit at least eight weeks before the expiry date at the immigration office responsible for your place of residence. |
| | The same requirements apply to the extension of the residence permit for the purpose of research as for the granting of a residence permit. In particular, you should be able to present a hosting agreement or a corresponding contract with a research institution. |

Sachverhalt

If you were obliged to take part in an integration course when your residence permit was first issued, this will be taken into account when your residence permit is extended. If you have not yet taken part in an integration course, the immigration authority may reject your application to extend your residence permit. If you have not yet completed the integration course, your residence permit will generally only be extended for one year at a time until you successfully complete the course or provide proof that you have been integrated into society and social life in another way.

If your residence permit is extended, it will be limited in time again. The residence permit for the purpose of research will be extended for the duration of the research project.

As a rule, the residence permit cannot be extended if this was already ruled out when the residence permit was issued or last extended.

Erforderliche Unterlagen

- Valid passport or passport substitute
- Existing residence permit
- Current biometric photo
- Hosting agreement or a corresponding contract with a research institution for the implementation of the research project
 - Tenancy agreement
- Proof of living expenses (including 3 proofs of income for the last 3 months)
 - Proof of your health insurance
- If you are obliged to attend an integration course: certificate of successful participation in the integration course or other proof of integration efforts

Voraussetzungen

- You have a recognized and valid passport or passport substitute and a valid residence permit for the purpose of research in accordance with Section 18d (1) AufenthG.
- Your residence permit will expire in the near future.
- There is no interest in deporting you.
- Your stay does not jeopardize or impair the interests of the Federal Republic of Germany.
- You can cover your living expenses and health

| Kurztext | Residence permit for the purpose of gainful employment Extension for the purpose of research Residence permits for the purpose of research can be extended if they are due to expire in the near future and the work at the research institution is to be continued. The extension must be applied for at least eight weeks before the expiry date. An extension of the residence permit for the purpose of research is only possible if the requirements that were met when the permit was first issued are still met. In the course of the extension, the residence permit is again limited in time. If the obligation to attend an integration course was stated when the residence permit was issued, proof must be provided that this obligation has been fulfilled. If the integration course has not yet been completed, the foreigners authority may refuse to extend the residence permit for one year until the course has been successfully completed or proof has been provided that integration into social life has taken place in |
