residence.

The same conditions apply for the extension as for the issue. In particular, you should continue to work in the IT sector and be able to demonstrate a certain salary.

The Federal Employment Agency approved your residence permit when it was first issued. If the validity of the approval has expired, it must be granted again for the extension of your residence permit.

You may have been obliged to take part in an integration course when your residence permit was first issued. If this is the case, this must be taken into account when extending your residence permit. If you have not yet taken part in an integration course, the immigration authority may reject your application to extend your residence permit. If you have not yet completed the integration course, the residence permit will generally only be extended for one year at a time until you successfully complete the course or provide proof that you have been integrated into society and social life in another way.

If your residence permit is extended, it will be limited in time again. The duration of the time limit depends on the duration of your employment contract or the period of validity of the approval of the Federal Employment Agency.

As a rule, the residence permit cannot be extended if this was already ruled out when the residence permit was issued or last extended.

- Current registration certificate
- Proof of your health insurance

substitute as well as a valid residence permit for the purpose of employment with a high level of practical professional knowledge.

- Your residence permit will expire in the near future.
- There is no interest in deporting you.
- Your stay does not jeopardize or impair the interests of the Federal Republic of Germany.
- You have a new employment contract or a new binding job offer with the same or another employer in the IT sector.
- Your salary will continue to reach at least 60% of the contribution assessment ceiling for pension insurance. In 2023, 60% corresponds to a gross minimum salary of EUR 4,380 per month or EUR 52,560 per year (limit applies to the whole of Germany). The amount of the minimum salary is announced each year by the Federal Ministry of the Interior and Home Affairs in the Federal Gazette by December 31 of the previous year (see further information).
- You can continue to secure your livelihood and health insurance cover independently without claiming public benefits.
- You have received or renewed approval from the Federal Employment Agency to take up employment (approval is usually obtained from the immigration authority). For approval to be granted, your working conditions (in particular salary) must be comparable to those of a German employee in the same position.

## Verfahrensablauf

You must apply for an extension of your residence permit at the foreigners authority responsible for your place of residence. The procedure is as follows:

- Depending on the foreigners authority and your request, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic application for a residence permit.
- If you can only apply in person, make an

appointment with the immigration office.  
 During the appointment, your application will be accepted and your supporting documents will be checked (bring these with you to the appointment).  
 Your fingerprints will be taken for the renewal of the electronic residence permit (eAT card).

- In the case of an electronic application, the Foreigners' Registration Office will contact you after receiving your application to arrange an appointment at the Foreigners' Registration Office. During the appointment, your documents will be checked (bring them with you to the appointment) and your fingerprints will be taken for the renewal of the electronic residence permit (eAT card).
- If your application is approved, the Foreigners' Registration Office will arrange for the eAT card to be issued.
- After about six to eight weeks, you can collect the eAT card from the immigration office.
- The eAT card must always be collected in person.
- Fees are charged for the extension of the residence permit. The time and form of payment vary depending on the authority.

- The extension should be applied for at least eight weeks before your valid residence permit expires.
- In the event of an extension, the new residence permit will again be issued for a limited period. The validity depends on the duration of your employment contract and the approval of the Federal Employment Agency.

The decision of the immigration authority can be appealed to the court named in the decision.

purpose of employment with extensive practical professional knowledge can be extended if the residence permit expires and the employment is to be continued.

- The extension must be applied for at least eight weeks before the temporary residence permit expires.
- The same conditions apply for the extension as for the issue.
- If the period of validity of the approval obtained when the residence permit was issued has expired, the approval of the Federal Employment Agency must be obtained again.
- If the obligation to attend an integration course was stated when the residence permit was issued, proof must be provided that this obligation has been fulfilled. If the integration course has not yet been completed, the foreigners authority can refuse to extend the residence permit or only extend it for one year until the course has been successfully completed or proof has been provided that integration into society and social life has taken place in another way.
- In the course of the extension, the residence permit is again limited in time.
- An extension is excluded if this was already ruled out by the immigration authority when the permit was issued or when it was last extended.
- Depending on the foreigners authority and your request, you can apply online or in person.
- Fees:
  - for a further stay of up to three months: EUR 96.00
  - for a further stay of more than three months: EUR 93.00
- Under certain circumstances, a fee reduction or fee exemption may be possible.
- Responsible: the foreigners authority responsible for the applicant's place of residence
