| Teaser | Once the equivalence of your foreign professional qualification has been successfully established or you have received a license to practice your profession in Germany, your residence permit can be extended for a maximum of 12 months for the purpose of finding a job. |
| Volltext | <p>If you have successfully had the equivalence of a foreign professional qualification determined or have received a permit to practice your profession, you can be granted a temporary residence permit to look for a job.</p> <p>The residence permit will be issued to you directly following your previous recognition procedure. An extension of the residence permit is only possible if the maximum period was not exhausted when the permit was first issued. If you do not find a job during this time, it will not be possible to extend your residence permit. You are then obliged to leave the federal territory.</p> |

appointment with the immigration office.
 During the appointment, your application will be accepted and your supporting documents will be checked (bring these with you to the appointment).
 Your fingerprints will be taken for the renewal of the electronic residence permit (eAT card).

- In the case of an electronic application, the Foreigners' Registration Office will contact you after receiving your application to arrange an appointment at the Foreigners' Registration Office. During the appointment, your documents will be checked (bring them with you to the appointment) and your fingerprints will be taken for the renewal of the electronic residence permit (eAT card).
- If your application is approved, the Foreigners' Registration Office will arrange for the eAT card to be issued.
- After about six to eight weeks, you can collect the eAT card from the immigration office.
- The eAT card must always be collected in person.
- Fees are charged for the extension of the residence permit. The time and form of payment vary depending on the authority.

- The extension should be applied for at least eight weeks before your valid residence permit expires.
- In the event of an extension, the new residence permit will again be issued for a limited period. The validity depends on the duration of your employment contract and the approval of the Federal Employment Agency.
- Deadline: 1 month
