Volltext	<p>The driver card is used to monitor driving times and rest periods in the commercial transport of goods and passengers. The obligation to have a driver card applies to:</p> <ul style="list-style-type: none"> <li>• Motor vehicles with a maximum permissible mass of more than 3.5 t including trailers;</li> <li>• motor vehicles with a maximum permissible mass of 2.8 to 3.5 t including trailers, provided that a digital tachograph is installed;</li> <li>• as well as for motor vehicles designed to carry more than nine persons including the driver.</li> </ul> <p>Exemptions arise from § 1 paragraph 2 and § 18 of the Driving Personnel Ordinance and Article 3 of - Regulation (EC) No. 561/2006.</p> <p>In case of theft, you must apply for the replacement of a driver card.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Address and proof of residence such as identity card with eID function (or residence permit or EU citizen card) as well as proof of birth and surname, first name, date and place of birth, mother tongue</li> <li>• current biometric photo</li> <li>• A current EU driving license or a comparable driving license for applicants from another EU/EEA country in the corresponding driving license class, which entitles the holder to drive vehicles for which the driving and rest periods in accordance with Regulation (EC) No. 561/2006 must be observed.</li> <li>• Confirmation from the police regarding the theft report.</li> </ul>

Voraussetzungen	<p>You are entitled to apply for the first issue of a driver card if you are</p> <ul style="list-style-type: none"> <li>• are resident in the Federal Republic of Germany and</li> <li>• hold a German EU-card driver's license with one of the following classes: B, BE, C1, C1E, C, CE, D1, D1E, D, DE.</li> </ul> <p>Driving licenses issued in a member state of the European Union (EU) or another state party to the Agreement on the European Economic Area (EEA) must correspond to one of the aforementioned classes.</p>
Kosten	The issuance is subject to a fee.
Verfahrensablauf	<p>You can apply for the replacement of your driver card with the required documents and information locally</p> <ul style="list-style-type: none"> <li>• at your local driver licensing authority in the county or city where you have your main residence for at least 185 days a year, submit your application.</li> <li>• When submitting your application, you must provide all the required information and documents.</li> <li>• The responsible authority will check your information for completeness and correctness.</li> <li>• After successful verification, the Federal Motor Transport Authority (KBA) will issue the personalized driver card.</li> <li>• After application and verification, the card will be issued within 8 working days. During this time, the driver may continue driving without a valid driver card for a maximum of 15 days. For the period in which the driver is not in possession of a driver card, printouts must be made from the digital tachograph and carried in a professional manner.</li> <li>• The personalized driver card can be collect the personalized driver card directly from theor Have it sent to you directly (after authentication and payment) from the KBA.</li> </ul> <p>Note:</p> <p>The authority that issued the driver card must be informed immediately of the loss of the driver card. 	<p>card loses its validity. A recovered card must be returned to the issuing authority.</p> <p>If serious violations (including both criminal offenses and misdemeanors) are found during the replacement process, the issuance of the driver card may be refused and the application may be rejected.</p>

Frist	In case of replacement issuance, the application must be submitted within 7 calendar days. The start of validity is the date of personalization (production) by the Kraftfahrt-Bundesamt (KBA). The end of validity of the driver card to be replaced corresponds to the end of validity of the previous stolen driver card if the remaining period of validity is more than 185 days.

Hinweise	In Germany, employers are not obliged to reimburse their employees for the cost of driver cards. The Federal Labor Court has ruled that employees are not entitled to reimbursement.
