Teaser	If you want to organize a fire, for example campfire or Easter fire, then you must notify the competent authority.
Volltext	If you want to hold a fire, you are obliged to notify the responsible municipality. The notification must be made at least one week before the event. It is irrelevant whether the fire is part of a public event or not.
Erforderliche Unterlagen	This is regulated in the municipal bylaws and varies from municipality to municipality.
Voraussetzungen	
Kosten	The costs are set by the municipalities in their respective bylaws.
Verfahrensablauf	For questions about the procedure, contact the relevant municipality.
Bearbeitungsdauer	Information on a processing time cannot be provided.
Frist	1 Woche(n) The notification must be made one week before the start of the event.
