Teaser	If you wish to conduct or broker sports betting, you must apply for a permit to do so.
Volltext	Public gambling on the occurrence or outcome of future events (sports betting) may be organized or brokered only with the permission of the competent authority. Organizing and brokering without such permission is prohibited. Permission to organize sports betting is granted nationwide by the Joint Gambling Authority of the Federal States (Halle (Saale)). Permitted organizers may also distribute their sports bets in betting brokerage offices in the federal states. This requires a separate permit from the federal state in which the betting agency is to be operated.

Voraussetzungen	A permit to broker sports betting requires a valid organizer's permit.

Organizing and brokering without such permission is prohibited. • Permission to organize sports betting is granted nationwide by the Joint Gambling Authority of the Federal States (Halle (Saale)). Permitted organizers may also distribute their sports bets in betting brokerage offices in the federal states. This requires a separate permit from the federal state in which the betting exchange is to be operated. • For the decision on an application for the granting of a permit for the brokerage of sports betting, fees of at least 1,000 euros maximum 3,000 euros are incurred per betting brokerage office. • Responsible: Thuringian State Administration Office (TLVwA)
