Teaser	Were you, your child or another close family member in the ascending or descending line of descent born abroad? Then you can have the birth subsequently certified in the birth register at the registry office responsible for you.
Volltext	If you or a close family member in an ascending or descending line of descent was born abroad, you can apply for subsequent certification of the birth in the birth register at the registry office in Germany.  You apply for the certification at the registry office that is responsible for your German place of residence or the German place of residence of the person entitled to apply. If neither a current nor a former German place of residence can be determined, you can apply for certification at your competent German mission abroad or at the Berlin I registry office.  You are not obliged to have the birth subsequently certified. Birth certificates from abroad are often recognized in Germany as long as their authenticity is beyond question.  However, the subsequent entry in the birth register can be advantageous because the local registry office can then issue you a German birth certificate. This

	means that you no longer have to have the foreign certificate translated and certified for future requests.
Erforderliche Unterlagen	<ul> <li>Application form for certification of a foreign birth in the birth register</li> <li>foreign birth certificate with translation; legalization or apostille if necessary</li> <li>valid identity card, passport or travel document</li> <li>marriage and birth certificates of the parents of the person to whom the entry refers</li> <li>naturalization certificate or citizenship certificate, if applicable</li> <li>If applicable, other documents with proof of authenticity and, if applicable, translation, depending on the individual case.</li> </ul> You must submit all documents in the original.

Kosten	The subsequent certification of a birth abroad is subject to a fee. In Thuringia, the fee for subsequent certification is € 90.00. A birth certificate created from the birth register costs € 10.00.
