Teaser	Under certain conditions, if you were enrolled at a university or (vocational) college in Germany on 01.12.2022, you can receive a one-off flat-rate energy allowance. You must apply for this.
Volltext	Students as well as pupils in vocational school classes whose attendance requires vocational training leading to a vocational qualification, pupils in vocational school classes and vocational school classes leading to a vocational qualification in a training course lasting at least two years, as well as pupils in comparable training courses can receive a one-off payment of 200 euros to relieve them of the increased energy costs. If you are one of the addressees and meet other requirements, you can submit an application for the one-off payment online using the procedure provided.
Erforderliche Unterlagen	 Access code (transmitted by the training center) PIN, if applicable (transmitted by the training center) IBAN from the SEPA area Applicants need a BundID account for identification in the application process.
Voraussetzungen	 From the higher education sector, this also includes, for example, part-time students, doctoral students, students on a semester off, students at universities of applied sciences or students on a dual study program. Students, Pupils in technical college classes whose attendance requires a vocational qualification, Pupils in (vocational) technical college classes that

	 provide a vocational qualification in a training course lasting at least two years, Pupils in training courses at higher technical colleges and academies, A distinction must be made between trainees: trainees in training courses at certain training institutions that are covered by a statutory instrument pursuant to Section 2 (3) no. 1 of the Federal Training Assistance Act (BAföG). You must belong to the addressees of the Student Energy Price Allowance Act belong. This includes Eligibility depends on the type of training institution they attend and the type of qualification they are aiming for. Trainees at a vocational college or technical college who are completing a vocational qualification lasting at least two years receive the one-off payment. This also applies to trainees attending a technical college class that requires a completed vocational qualification. Persons who have completed a study visit/internship abroad limited to a maximum of two semesters and were still enrolled/registered at their educational institution in Germany at the same time generally have their habitual residence in Germany.
Kosten	There are no costs involved.
Verfahrensablauf	 You can apply digitally for the energy price flat rate for students, technical students. You set up a BundID account with the eID function of your ID card, with your ELSTER certificate, your electronic residence permit, your EU identity or your EU citizen card. Alternatively, set up a BundID account as a basic registration with username/password. You will receive an access code and, if necessary, a PIN from your training institution. You register on the website with your BundID account. You enter the access code (and PIN, if applicable) provided by your training institution into the application form. You provide the other required information, in particular the IBAN of your account, a joint account or a third-party account.

	 Once you have sent your application, it will be transmitted to the relevant office in the country and checked (fully) automatically in the relevant country-specific procedure. As a rule, you will receive your approval notice within a few minutes. The energy price flat rate is usually paid out within a few working days.
Bearbeitungsdauer	The processing of applications up to approval usually takes only a few minutes. Payment is usually made within a few days of approval.
Frist	The application must be submitted no later than September 30, 2023.

The residence or habitual abode of the applicant must be in Germany. Students in gainful employment who have received the energy allowance of 300 euros for those in gainful
