Volltext	If you want to go hunting in Germany, you need a German hunting license in your name. If your German hunting license has been revoked, you can reapply for it at the authority responsible for your place of residence after the specified ban period has expired.

Verfahrensablauf	You can submit the application in writing or online, if available. • If you submit the application in writing, fill it out and submit it by mail or in person to the competent authority. • The application and the evidence to be submitted will be checked for completeness and correctness. • If you meet all the requirements, you will be issued a hunting license.
