Volltext	If you want to erect new buildings, make changes to buildings or change their use, you will need planning permission. This does not apply to smaller building projects for which certain conditions apply. You can also make use of the simplified procedure in your application. Projects for which planning permission is required, which can probably be granted in a simplified planning permission procedure: This applies to smaller projects, such as detached and semi-detached houses and other comparable buildings. These can be examined in a simplified building permit procedure. The Thuringian Building Code regulates exactly which projects this applies to. The simplified building permit procedure is less complex.

Kosten	The fees depend on the chargeable building value in accordance with the administrative cost schedule of the Building Fees Ordinance.
Verfahrensablauf	Submit a building application to the responsible authority.

Frist	A decision on the building application will be made within three months of submission of the complete application documents.
