Volltext	<p>Special obligations apply to events with animals. As an event organizer, you must report certain animal events at different locations. This includes</p> <ul style="list-style-type: none"> • non-commercial circus operations • the commercial exhibition of animals • and other establishments where animals are put on display <p>You must notify the competent authority at the venue of these types of animal events at changing locations prior to arrival.</p> <p>Under certain circumstances, the competent authority may restrict or prohibit events of this type.</p> <p>This may be necessary in the event of an animal epidemic, for example. The competent authority will inform you of any restrictions or bans.</p>
