| Volltext                         | If you were imprisoned for at least 90 days and the imprisonment was not compatible with the fundamental principles of a free constitutional order, you can receive a special allowance for victims of imprisonment. The allowance amounts to EUR 330 per month.  The following persons may be affected, for example • Victims of the SED regime who were imprisoned in the former GDR for political reasons in violation of the rule of law • Victims of the SED regime who were committed to a psychiatric institution or placed in a home for children or adolescents in the former GDR for political or other irrelevant reasons.  You must have been rehabilitated by a court because of the deprivation of liberty contrary to the rule of law. Your income must not exceed certain income limits. The following income is not taken into account: • old age • reduced earning capacity • an accident at work or an occupational disease • death or comparable benefits • Pensions due to • employment promotion allowance • child benefit The allowance is non-seizable, non-transferable and non-inheritable.  You cannot receive the special allowance for victims of imprisonment if you have been sentenced to at least 3 |
