Volltext	Children born in Germany to foreign parents can acquire German citizenship by birth under certain conditions. Foreigners who have had their legal habitual residence in Germany for eight years and meet the other naturalization requirements are entitled to naturalization. Under certain conditions, naturalization is also possible on a discretionary basis.
