Teaser	Income tax is a tax levied on the income of natural persons.
Volltext	The income tax is a Tax levied on the income of natural persons. Income tax is one of the state's most important sources of revenue. The basis of assessment is the taxable income. Numerous regulations (e.g. tax allowances, exemption limits, lump sums, special expenses, extraordinary burdens, variable tax rate) take into account your personal capacity as a taxpayer. Expenses for private living (regularly e.g. expenses for food, clothing, housing) may not be deducted as business expenses or income-related expenses. This also applies to such expenses that the taxpayer's economic or social position entails, even if they further his/her profession or activity. The federal and state tax administrations have developed a procedure for the electronic transmission of tax return data (My ELSTER) to the tax offices.
Erforderliche Unterlagen	• Income tax return • Registration "My ELSTER" if necessary Registration is required for submitting the income tax return via the tax authorities' service portal "My ELSTER". • Profit determination documents (balance sheet, profit and loss statement, attachments to the profit determination, if applicable) You can also find out which documents are required in detail from the notes in the respective tax return form.

Voraussetzungen	Income tax is levied on income from • Agriculture and forestry, • business operations, • self-employed work, • non-self-employed work, • capital assets • renting and leasing, and • other income such as income from a pension from the statutory pension insurance or income from private sales transactions.
Kosten	There are no fees to pay.
Verfahrensablauf	
Bearbeitungsdauer	How long it takes to process an income tax return or to assess income tax always depends on the circumstances of the individual case.
Frist	Submission deadline of the income tax return is in principle: • 31.07. of the calendar year following the tax period, if you are not advised for tax purposes • 28.02. or 29.02. of the second calendar year following the taxable period, if you are advised for tax purposes

Formulare	The income tax return must generally be submitted electronically if you generate income as a farmer, forester, trader or freelancer. In other cases, voluntary electronic submission is possible. The tax software required for this is available from many commercial providers. However, the income tax return can also be prepared and submitted free of charge via the online portal of the tax authorities ("My ELSTER").
