Teaser	Before operating your temporary structures, you must have them inspected for safety and apply for a permit for public use.
Volltext	Temporary structures can be amusement rides, tents, stands, stages and similar structures.
	These require a building permit before they are erected and put into use for the first time.
	The construction permit is issued for a limited period and can be extended upon application.
	The construction permit and its extension are issued by the supreme building supervisory authority or other authorities commissioned by it, for example TÜV, state inspection authorities and so on.
	A technical on-site inspection precedes the granting of the building permit and its extension.
	The periods until the necessary extension vary according to the potential risk and are between one and five years.
	When the building permit is granted, the issuing authority prepares an inspection log for the temporary structure. In addition to technical documents, it contains the construction permit, its extensions and, if necessary, the required conditions.
	The erection of the temporary structure must be

	reported to the responsible lower building supervisory authority and the inspection logbook must be submitted.
	This authority decides on a prior acceptance of use.

Frist	The work permit is valid for between one and five years, depending on the type of installation and design. It can be extended by the relevant period upon request.

Hinweise	The execution permit is entered in an inspection logbook. The building documents with the approval note must be attached to the inspection logbook. Construction permits from other federal states are also valid in the Free State of Thuringia.

Kurztext	The Building Inspection/Building Technology Division of the Building and Regional Planning Department of the Thuringian State Office of Administration issues building permits and carries out stability tests.
