Teaser	A change of use is a change to the approved type of use of a building. When registering a business, for example, it is advisable to obtain information from the building supervisory authority in advance.
Volltext	A change of use is a change to the approved type of use of a building. In most cases, the change of use - even without structural changes - requires planning permission. The change of use application is examined either in the permit exemption procedure, in the simplified building permit procedure or in the full procedure. When registering a business, for example, it is advisable to find out in advance from the building supervisory authority whether the desired use of a building/room constitutes a change of use requiring approval.

Kurztext	A change of use is a change to the approved type of use of a building. The change of use must be applied for. When registering a business, for example, it is advisable to find out in advance from the building supervisory authority whether the desired use of a building/room constitutes a change of use requiring approval. In Thuringia, the lower building supervisory authorities are responsible for applying for a change of use for buildings.
