Otherwise, the following persons are obliged to report a death in the following order:</p> <ol style="list-style-type: none"> <li>1. any person who lived with the deceased in a domestic relationship,</li> <li>2. the person in whose home the death occurred,</li> <li>3. any other person who was present at the death or who is aware of the death from his or her own knowledge. (If a funeral home registered with a chamber of commerce or chamber of industry and commerce is entrusted with the notification, the funeral home may file the notification).</li> </ol> |
