Bearbeitungsdauer	The registration court must decide on the registration immediately after receipt of the application. If all documents are available and no objections by the court are necessary, registrations are usually made within a few working days.

- Procedure: To apply for registration, you must contact a notary public. The notary will advise on the formulation of the application. The application is made exclusively by electronic means, and a publicly certified document is prepared for this purpose. The declaration is provided with a qualified electronic signature and sent to the electronic court mailbox of the registry court. The registration court disposes of the registration in the internal court database and also publishes the registration on the Internet.
- Required documents:
 - publicly certified application to the Commercial Register
 - Depending on the legal form of the company and the type of facts to be registered, further documents must be submitted (in some cases also certified by the notary)
 - The notary public and the IHK can provide information on which documents must be submitted in each individual case.
 - Fees will be charged.
 - Responsible: Local court
