they are for possible future self-employment. The master craftsman examination comprises four legally independent parts, which must be completed independently of each other:

- Part I: Specialist practice
- Part II: Specialist theory
- Part III: Economic and legal principles
- Part IV: Vocational and work education

Passing the master craftsman examination confers the following qualifications:

- Use of the title "Master Craftsman"
- Independent management of a craft business after entry in the register of craftsmen
- Training apprentices.

You can obtain information on this at www.meister-bafoeg.info or from your Chamber of Crafts or the State Administration Office. According to the Thuringian Higher Education Act § 60 (1), successful completion of the master craftsman examination entitles the holder to enrol in a university course.
