This affects companies that place sales packaging on the market and exceed a certain quantity threshold. The declarations of completeness must be digitally signed by a recognized auditor (auditor, expert, tax consultant). The chambers of industry and commerce are tasked with maintaining the register for these declarations of completeness. The Chambers of Industry and Commerce provide advice on the register entries and the Packaging Ordinance.
