Permission is granted to anyone who • has proven their expertise in accordance with § 5 ChemVerbotsV, • has the required reliability and • is at least 18 years old. Companies are granted permission for their facilities and operations if they have employees who meet the

	aforementioned requirements. The permit can be limited to individual dangerous substances and preparations or to groups of dangerous substances and preparations. It may be granted subject to conditions. Conditions may also be imposed subsequently. The following do not require a permit • Pharmacies, • manufacturers, importers and distributors who supply substances and preparations in accordance with paragraph 1 only to resellers, professional users or public research, testing or teaching institutes.
Erforderliche Unterlagen	Documents with which you prove that you meet the above-mentioned requirements for the granting of a permit. Section 5 of the Chemicals Prohibition Ordinance (Chemikalien-Verbotsverordnung) specifies how the required expertise is verified.

Hinweise	Sufficient expertise is a prerequisite for the permit. If the entrepreneur is not competent himself, persons with expertise must be employed in his company who are competent for the corresponding activities. Qualified persons can be e.g. druggists, pharmacists, PTAs, retailers, plant managers, etc. For some of these

persons, it is assumed by the legislator that they have acquired the expertise as part of their training. Other persons have to pass an additional examination for expert knowledge at the competent authority.

- If you want to commercially market substances or preparations that must be labeled with the hazard symbols T (toxic) or T+ (very toxic) according to the Hazardous Substances Ordinance, you need a permit.
- Certain requirements must be met.
- Fees are incurred.
- Responsible: as a rule, the counties and independent cities. In exceptional cases (in the case of self-impact), the Thuringian State Administration Office.
