Volltext	<p>Hoof and claw shoeing in Germany may only be carried out by certified and state-approved farriers. This does not apply to the practice of shoeing by employees subject to social insurance contributions or trainees, insofar as they work under the supervision of farriers. This also excludes veterinary work and work that is merely concerned with the usual everyday cleaning and care of hooves and claws.</p> <p>Hoof shoeing includes the totality of all operations performed on a hoof for the purpose of protection, health maintenance, correction or treatment. Hoof shoeing includes the totality of all operations involved in the application, repair, or removal of a shoe to the hoof of an animal when that animal is to be used as a draft, pack, or riding animal.</p> <p>The specialized training at farriery schools may only be carried out by certified and state-approved farriery</p>

instructors.

Examination certificates in the field of farriery and hoof shoeing obtained outside Germany may be treated as equivalent in accordance with the Farriery Recognition Ordinance. This ordinance also regulates the procedure for state recognition for persons with equivalent examination certificates.

Erforderliche Unterlagen

The certificates and documents proving the existence of the aforementioned requirements are required.

Translations of documents in foreign languages must always be submitted in German. At the request of the competent authority, these must be prepared by a publicly appointed or sworn interpreter or translator.

Voraussetzungen

The requirements for state recognition as a farrier or farrier's apprentice or as a farrier's apprentice with training completed in Germany are set out in Sections 4 and 5 of the Farriery Act and Sections 1 and 2 of the Farriery Ordinance.

The requirements for state recognition for persons with examination certificates obtained outside of Germany, who are recognized and treated as equivalent in accordance with the above procedure, are governed by §§ 3 and 4 of the Farriery Recognition Ordinance.

According to this, the following are required for recognition as a farrier

- an equivalent examination certificate,
- proof of the reliability required to exercise the profession (application for a certificate of good conduct or submission of a confirmation from the country in which you obtained the examination certificate showing that you have not committed any animal welfare violations).

In order to be recognized as a farrier's apprentice, the following requirements must also be met:

- a minimum of five years working as a farrier or farrier's apprentice,
- annual attendance of further training courses during this period and
- the required professional and occupational pedagogical knowledge.

Kosten

For the recognition of an examination certificate according to § 2 Para. 1 in connection with Para. 2 or 3 of the Hufbeschl-Anerkennungsverordnung (HufBeschl-AnerkennV) a fee range of 30 to 120 EUR is set. For the recognition of an examination certificate according to § 2 Para. 1 in connection with Para. 4 HufBeschl-AnerkennV a fee range of 60 to 350 EUR applies.

For the recognition as a farrier according to § 3 para. 2 HufBeschl-AnerkennV including the issuance of a certificate, a fee range of 30 to 80 EUR is set. For the recognition as a certified farrier according to § 4 para. 2 HufBeschl-AnerkennV including the issuance of a certificate, a fee range of 30 to 100 EUR applies.

A fee of 30 EUR applies for the recognition as a certified farrier according to § 1 para. 1 Hufbeschlgesetz (HufBeschlG) or as a certified apprentice farrier according to § 2 para. 1 HufBeschlG. This does not include the fee for the farriery examination according to § 9 HufBeschlG or the fee for the farriery apprentice farriery examination according to § 18 para. 1 HufBeschlG.

Verfahrensablauf

If you have successfully completed the training and examination as a farrier in Germany regulated by the German Farriery Ordinance (Hufbeschlverordnung) or have successfully completed the further training and examination as a farriery instructor in Germany regulated by this Ordinance and can prove that you have the necessary reliability to practice the profession, you will be granted state recognition by the competent state authority.

In the case of examination certificates obtained abroad, you must submit an application in

writing/electronically to the competent authority of the federal state in which you wish to practice farriery and hoof shoeing or teaching at a farriery school for the first time in order to obtain state recognition as a farrier or farriery instructor. The competent office will confirm receipt of the submitted documents within one month and will inform you if any documents are missing for the decision on your application.

The further procedure is determined by §§ 2 to 4 of the Hufbeschl-Anerkennungsverordnung (HufBeschl-AnerkennV).

The examination certificates listed in Appendix 1 to the HufBeschl-AnerkennV are automatically recognized as equivalent to the certificates for the examination to become a farrier and are treated as equivalent if, in addition to the corresponding examination certificate, the applicant provides evidence of having attended a regulated and relevant training course of at least two years.

The examination certificates listed in Annex 2 to the HufBeschl-AnerkennV are automatically recognized as equivalent to the certificates for the examination to become an apprentice farrier.

If automatic recognition of the examination certificates cannot take place, an equivalence test will be carried out if the acquired examination certificates and professional qualifications in the country of origin entitle the holder to practice the profession of farriery apprentice blacksmith or farriery apprentice blacksmith. If there are significant differences in the qualifications, an adaptation course or aptitude test may still have to be completed. Prior to this, it is checked whether the skills, knowledge and abilities acquired in the course of professional practice fully or partially compensate for the substantial differences. In the case of examination certificates and professional qualifications recognized by the European Federation of Farriers' Associations (EFFA), it is regularly assumed that they are equivalent to the skills, knowledge and abilities demonstrated by the farrier's examination passed in Germany.

	You will be issued with a certificate of state recognition as a farrier or farrier trainer.
Bearbeitungsdauer	The decision on the equivalence of an examination certificate obtained abroad and the state recognition as a farrier or farrier apprentice farrier in accordance with the Farrier Recognition Ordinance is made within three months. This period may be extended by one month in justified cases that are particularly difficult to assess.
Frist	The application for state recognition as a farrier or farrier apprentice farrier or farrier apprentice farrier must be submitted in a timely manner prior to practicing farriery and hoof trimming.

Hinweise	Any person who intentionally or negligently engages in hoof and claw shoeing as a farrier or farrier's apprentice without the required state certification or in the specialized training at farrier's schools as a farrier's apprentice acts in violation of the regulations (§ 9 HufBeschlG).
Rechtsbehelf	You can appeal against the decision on your application or against a decision not made in due time in accordance with the Administrative Court Code (objection, if necessary action before the Administrative Court).
