Volltext	Anyone who wants to use a professional title in one of the following health care professions needs a permit: • Registered nurse • health care and nursing professional • Health care and pediatric nurse practitioner • Medical technologist for laboratory analysis, radiology or functional diagnostics • Pharmaceutical technical assistant (m/f) • Emergency paramedic • Speech therapist • Midwife • Dietary assistant • Orthoptist • Physiotherapist • Occupational therapist • Masseur and medical bath attendant • Podiatrist • geriatric nurse • Anaesthesia technical assistant/ Surgical technical assistant • geriatric nurse or nurse assistant

Voraussetzungen	You must have completed the prescribed training and passed the state examination in the Free State of Thuringia. You must prove that you are fit to practice the respective profession from a health point of view and that you have not been guilty of any behavior that would make you unreliable to practice the profession.
Kosten	Upon issuance of the permit, fees of 80.00 euros will be charged.
