Teaser	If your stay in an accommodation facility exceeds six months, you must register with the relevant registration authority.
Volltext	<p>If you are accommodated in a place of accommodation, you must register with the registration office as soon as your stay exceeds six months.</p> <p>If you do not have a home within Germany, you must register after just three months.</p> <p>As a guest of an accommodation facility (hotel, guesthouse, inn and similar), you must sign a special registration form by hand on the day of arrival.</p> <p>The number of accompanying family members must be stated on the registration form. For tour groups of more than 10 people, the tour guide must sign the special registration form; he/she must indicate the number of fellow travelers and their nationality.</p> <p>The special registration forms must be presented by the accommodation provider to certain authorities for inspection upon request in order to fulfill their duties.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> • Identity card or passport • Confirmation from the landlord <p>If you are a foreigner, you must provide a valid identity document.</p>
Voraussetzungen	In the case of persons under 16 years of age, care must be taken to ensure that they are registered by the persons into whose dwelling they move.
Kosten	There are no fees.

Frist	They must register within two weeks as soon as their stay exceeds six or three months.

Hinweise	The described information concerns the case of "living" in the accommodation facility (hotel, boarding house). For short stays, which are typical in practice, special registration forms for lodging establishments are used.

Kurztext	<ul style="list-style-type: none"> • If you are accommodated in a place of accommodation, you must register with the registration office as soon as your stay exceeds six months. • If you do not have an apartment within Germany, you must register after only three months. • Special registration form must be filled out on the day of arrival at the boarding house/hotel. • The competent authority is the registration office in whose area of responsibility the place of accommodation is located.
Ansprechpunkt	Contact the manager of the accommodation facility or his/her representative (reception) or your registration authority.
Zuständige Stelle	The accommodation facility and, if applicable, the registration authority in whose jurisdiction the accommodation facility is located.
Formulare	The special registration form is provided by the manager of the accommodation facility or his/her authorized representative.
