Teaser	In order to work temporarily in Germany as a veterinarian without a license, you need a permit.
Volltext	<p>If you have completed training as a veterinarian but do not have a license to practice medicine and only wish to practice the veterinary profession temporarily, you will need a permit.</p> <p>The permit entitles you to use the professional title "veterinarian".</p> <p>The permit can be restricted to certain activities and employment positions. It may only be granted or extended on a revocable basis and only up to a maximum total duration of four years of veterinary activity. A further grant or extension of the license is possible under certain conditions. possible.</p>

Erforderliche Unterlagen

The following documents must be submitted:

- Application for permission to temporarily exercise the veterinary profession,
- Proof of citizenship (certified copy of identity card, passport or proof of identity),
- the birth certificate or an extract from the family register of the parents, in the case of married persons also the marriage certificate or an extract from the family register kept for the marriage,
- proof of professional qualification (veterinary diploma, examination certificate or other proof of veterinary qualification/training),
- if applicable, certified proof of recognition of asylum, permission under the Residence Act or possession of a naturalization certificate
- Signed curriculum vitae in tabular form: up-to-date, concise and with a detailed, complete description of the applicant's education and professional career
- Certificate from the future employer about the employment opportunity and justification (e.g. employment contract, needs assessment)
- Proof of no criminal record, certificate of good conduct for submission to an authority (this proof must not be older than 3 months at the time of application)
- Medical certificate stating that you are fit to practise the veterinary profession from a health point of view (no official medical certificate required, this certificate must not be older than 3 months at the time of application)
- proof of the German language skills required to carry out the intended professional activity (only for applicants from non-German-speaking EU/non-EU/EEA countries).

The documents can be sent to the competent authority without any specific formal requirements.

Note: Foreign-language documents must be accompanied by a German translation. The translation must be carried out by an officially sworn document interpreter. Diplomas and certificates of veterinary training must be submitted in a certified translation.

If you are a national

- a member state of the EU,
- another state party to the Agreement on the European Economic Area or
- a contracting state to which the EU member states have granted a corresponding legal entitlement by treaty,

and you have obtained your training certificate in one of these states, you must demonstrate with your application that, with regard to the intended veterinary activity, there is a particular interest in the granting of a license instead of a license to practice medicine.

Documents issued in a member state of the European Union or in another state party to the Agreement on the European Economic Area can also be submitted electronically by EU nationals. In the event of reasonable doubt as to the authenticity of the documents submitted and where absolutely necessary, the licensing authority may also request the submission of certified copies in this case.

Voraussetzungen

To obtain a permit for the temporary practice of the veterinary profession

- you must provide evidence that you have completed training for the veterinary profession
- you must not have been guilty of any conduct that makes you unworthy or unreliable to practise the veterinary profession
- you must not be medically unfit to practise the veterinary profession
- you must have the necessary German language skills for the job at level B2 according to the Common European Framework of Reference for Languages and
- you need proof of a specific job.

Kosten

A fee range of EUR 60 to 120 has been set for the granting of a permit for the temporary exercise of the veterinary profession and a fee range of EUR 30 to 100 for the extension of the permit.

	Additional costs may be incurred (e.g. for translations or certifications). These costs vary from person to person.
Verfahrensablauf	<ul style="list-style-type: none"> • For a permit to practice the veterinary profession on a temporary basis, you must submit an application in writing or electronically to the competent authority of the federal state in which the veterinary profession is to be practiced. • The competent authority will decide on the permit after examining your documents.
Bearbeitungsdauer	A decision on the application will be taken within three months of submission of the complete documentation. The deadline may be extended by one month.
Frist	The application must be submitted before you start working as a veterinarian.

Hinweise	<p>If the applicant cannot be granted a license or permission to temporarily practice the veterinary profession, the competent authority shall examine whether the practice of certain veterinary activities can be approved under the conditions of Section 15b of the Federal Veterinary Code. In this case, the authority will contact the applicant.</p> <p>Engaging in veterinary activities before a permit for the temporary exercise of the veterinary profession has been granted may result in criminal prosecution consequences.</p> <p>All veterinarians who practise their profession in Thuringia or, if they do not practise their profession, have their habitual residence there, are members of the Thuringia State Chamber of Veterinarians (with the exception of veterinarians working in the supervisory authority and veterinarians who only practise the profession temporarily and occasionally within the framework of the movement of services under European law). Every member of the Chamber must register with the State Chamber of Veterinary Surgeons and the competent veterinary and food monitoring</p>

	<p>office within one month of commencing professional activity.</p> <p>The license is revocable and is generally only granted or extended for a maximum total period of four years of employment as a veterinarian. As a rule, it is limited to a specific employment position and does not entitle the holder to carry out sovereign tasks.</p>
Rechtsbehelf	You have the right to appeal against a decision on your application in accordance with the Administrative Court Regulations (objection, if necessary, legal action before the Administrative Court).
Kurztext	<ul style="list-style-type: none"> • Permission for temporary practice of the veterinary profession Issuance for veterinarians from EU member states. • For the temporary practice of veterinary medicine in Germany, a state license (Approbation) is required. If this is not available, a permit is required. • This permit must be applied for at the competent authority of the country in which you wish to work as a veterinarian. • Proof of completed training for the veterinary profession must be provided. • Fees will be charged. • Application must be made prior to practicing as a veterinarian. • Responsible: Thuringian State Office for Consumer Protection (TLV).
