Volltext	<p>If you wish to conduct legally ordered public auctions (e.g. forced pledge sales or distress sales), you require a public appointment for this. The owner of the auctioned property has no influence on the price and the minimum bid and must therefore be able to rely on the fact that his property interests will be represented in a particularly qualified manner at the auction. You must therefore prove that you have special professional knowledge and a high degree of personal reliability.</p> <p>As a publicly appointed auctioneer, you are sworn to carry out your duties conscientiously, impartially and free from instructions.</p> <p>The appointment can be general or limited to certain types of auctions, provided there is a need for auctioneer services. It can also be restricted in terms of content, limited in time and subject to conditions. be associated with conditions. The appointment is valid for the whole of Germany.</p> <p>The appointment can only be requested for you as a natural person and not for a company.</p>

- For self-employed persons: Proof of auctioneer's license
- For employees:
  - Certified copies of all relevant certificates
  - Certificate of exemption from the employer
  - Certificate of good conduct for submission to an authority
  - Clearance certificate from the tax office
  - If applicable, list of auctions held in recent years
  - If applicable, information from the debtor register of the local court
  - If applicable, information from the insolvency register of the local court
  - Exemplary auction catalogs, if applicable
  - Extract from the central trade register, if applicable
  - Liability insurance, if applicable

## Voraussetzungen

- • You have an auctioneer's license
  - With a general public appointment and swearing-in: You have above-average specialist knowledge and experience in the valuation of valuables that are typically are typically lent in pawnshops, such as carpets, furs, jewelry, furniture, art and household and household goods. This is the so-called "general special expertise".
  - With public appointment and swearing-in for certain types of auctions: You can prove special knowledge in the field for which the public appointment and public appointment and swearing-in has been applied for
  - You are familiar with all relevant provisions of the Trade Regulations, the Auctioneers Ordinance, the Commercial Code and the Civil Code, concerning the responsibilities, rights and obligations of an auctioneer.
  - You have several years of professional experience as an auctioneer (conducting several auctions per year)
  - You must have been practicing the auctioneering trade the auctioneer's trade as particularly trustworthy. have proven themselves.
  - The suitability as a publicly appointed and sworn auctioneer must not have the slightest reservation exist. They must demonstrate impartiality and independence as well as compliance with the duties of a publicly appointed and sworn auctioneer
