Teaser	If you want to drive into an environmental zone, you need a fine dust sticker (environmental badge). You can get information here.
Volltext	Clean air plans exist for areas with poor air quality. Clean air plans contain measures to improve air quality. The establishment of environmental zones is one measure of such clean air plans. Environmental zones are intended to reduce particulate matter and nitrogen dioxide pollution. Only vehicles bearing the appropriate sticker on their windshields are allowed to drive in designated environmental zones. This applies not only to through traffic, but also to residents in environmental zones. If you want to drive your vehicle in such an environmental zone, you must purchase a fine dust sticker (environmental sticker).
	The assignment of the pollutant groups is regulated in

the Thirty-Fifth Ordinance for the Implementation of the Federal Immission Control Act.

The ordinance applies to all motor vehicles of class M (passenger cars/motor homes) and N (trucks), regardless of the type of drive (internal combustion engines - gasoline, diesel or gas - and electric drive).

Vehicles registered abroad also require the sticker to be allowed to enter low emission zones. This marking of low-emission vehicles is intended to help reduce particulate pollution, especially in cities.

The stickers in the colors red, yellow and green each correspond to a pollutant group:

- Green sticker = pollutant group 4: Motor vehicles with the lowest particulate or pollutant emissions, such as motor vehicles with the latest diesel technology and almost all motor vehicles with gasoline engines that have a regulated catalytic converter.
- Yellow sticker = Pollutant group 3: Diesel passenger cars with emission code numbers (ESN) 30, 31, 36, 37, 42, 44 to 52, 72 Diesel commercial vehicles with ESN 34, 44, 54, 70, 71
- Red sticker = pollutant group 2: Diesel passenger cars with emission code numbers (ESN) 25 to 29, 35, 41, 71 Diesel commercial vehicles with ESN 20, 21, 22, 33, 43, 53, 60, 61
- No sticker = pollutant group 1: Vehicles with a worse classification cannot be issued a sticker at all.

Erforderliche Unterlagen

The vehicle registration document (for older vehicles) or the registration certificate Part I (for newer vehicles). The vehicle itself does not have to be presented.

Voraussetzungen

In order to obtain an environmental badge, your vehicle must meet the criteria of pollutant groups 2, 3 or 4.

You cannot obtain a sticker for vehicles in pollutant group 1. These are

	 older diesel vehicles with emission standard Euro 1 or worse.
Kosten	The price for a badge is set by the issuing offices themselves. As a rule, it costs between 5.00 and 10.00 euros (including VAT).
Verfahrensablauf	
Bearbeitungsdauer	In most cases, you will receive the sticker immediately.
Frist	There are no deadlines to be observed.

Hinweise	If you are planning to drive into an environmental zone, make every effort to purchase a fine dust sticker as early as possible. If there are delays and you do not have a fine dust sticker, you will not be allowed to drive in the low emission zone. The following vehicles are generally allowed to drive in the low emission zone without a sticker: • mobile machines and devices • working machines • agricultural and forestry tractors • two- and three-wheeled motor vehicles • ambulances, doctor's cars with appropriate marking used for medical care of the population • motor vehicles driven or driven by persons who are exceptionally disabled, helpless or blind and who prove this by the symbol "aG", "H", "Bl" in the severely disabled person's identity card • Vehicles for which special rights can be claimed • Vehicles of non-German troops within the scope of military cooperation • Civilian vehicles on behalf of the Bundeswehr for journeys that cannot be postponed for the performance of sovereign tasks. • vintage cars , as well as vehicles registered in another Member State of the European Union, another contracting party to the Agreement on the European Economic Area or Turkey, if they meet equivalent requirements. The license plates of vehicles covered by

this exemption and registered in Germany end with an H. In the case of red license plates, the number after the distinguishing letter of the registration district begins with 07.

On the basis of clean air plans, local authorities can determine which areas are to be designated as temporary or permanent environmental zones.

In special, justified cases, the responsible road traffic authority (road traffic authority in whose district the environmental zone has been ordered) can approve temporary exceptions to the traffic prohibitions associated with the environmental zone upon application.

Further information on low emission zones is available from the Federal Ministry of Transport, Building and Urban Affairs (BMVBS) and the Federal Ministry for the Environment, Nature Conservation and Nuclear Safety (BMU).
