drawn up for several employers or particularly hazardous work and a safety and health protection coordinator must be appointed in accordance with § 4.

Any person who intentionally or negligently fails to provide the competent authority with advance notice, or fails to do so correctly, completely or in good time, shall be deemed to have committed an administrative offense within the meaning of Section 25 (1) No. 1 of the Occupational Health and Safety Act.
