Teaser	Exceptions to the ban on truck driving on Sundays and statutory holidays are possible under certain circumstances. You must apply for these at the responsible office.
Volltext	On Sundays and public holidays, trucks with a gross vehicle weight of more than 7.5 tons and trailers behind trucks are not permitted to drive between midnight and 10 pm. This ban does not apply to certain goods (e.g. various perishable foodstuffs). Under certain conditions, an exemption may be granted upon request.
Erforderliche Unterlagen	Evidence of the need for a special permit for the specific circumstances. Written application with reasons (in particular the urgency), indication of the route, business license, vehicle registration certificate, certificate of the client, if necessary further documents required by the competent authority.
Voraussetzungen	The transport must be urgent. Economic or competitive reasons are not sufficient.
Kosten	According to the Fee Regulations for Road Traffic Measures (GebOSt), there is a general fee range of 10.20 euros to 767.00 euros for a decision on an exception to the traffic ban for trucks (Geb.-Nr. 264).
Verfahrensablauf	The exemption must be applied for in writing. An application form is usually available for download from the responsible office.

	If an exception to the driving ban can be considered, a notice of approval including requirements and conditions is issued for the transport.
Bearbeitungsdauer	Depending on the individual case and involvement of other agencies.
Frist	As a rule, no deadlines apply, but an application should be submitted as early as possible.

Hinweise	The transport must be urgent. Economic or competitive reasons are not sufficient.
Rechtsbehelf	The decision (administrative act) on an application may be appealed by means of an objection/complaint.
Kurztext	• An exemption from the ban on driving on Sundays and public holidays can be granted upon application under certain conditions. • Written application must be submitted. • Responsible: Local road traffic authorities, Thuringian State Administration Office (Department 520)
Ansprechpunkt	Locally responsible road traffic authorities
Zuständige Stelle	The road traffic authority in whose district the load is picked up, or the road traffic authority in whose area of responsibility the applicant has his place of residence or registered office or the company carrying out the transport has its registered office or a branch office. The authority is then also responsible for approving the empty run to the place of loading. If the place of residence or registered office is abroad, the authority in whose district the permit is used for the first time is responsible.
