| Volltext                         | Municipal foreigners and integration officers are<br>advocates for foreigners in the region and stand up for<br>their rights. This results in a mediating function<br>between foreigners and authorities and also between<br>the German population. For reasons of integration<br>policy, the municipal commissioners for foreigners and<br>integration are now responsible for all people with a<br>migration background who require integration<br>assistance and are perceived by the population as<br>immigrants or foreigners. The commissioners<br>themselves have no right to issue directives.<br>Cooperation with the offices and authorities is based<br>on trust. |
|                                  | They deal with inquiries from the domestic and foreign<br>population on questions concerning foreigners and<br>advise individuals on related issues, insofar as these<br>cannot be solved or dealt with by counseling centers of<br>the independent institutions. They counteract<br>unjustified unequal treatment insofar as it affects<br>foreigners.  |
|                                  | The commissioners for foreigners and integration are<br>contact persons for social groups (associations,<br>churches, trade unions, social associations, foreigners'<br>advisory councils) and perform coordinating tasks for<br>them. The tasks they perform are voluntary services<br>provided by the local authority within the framework of<br>local self-government. Legal requirements only refer to<br>the protection of trust, which is necessary for their<br>work with this group of people. Foreigners' and<br>integration officers are only obliged to provide<br>information about this group of people if this does not  |
