Volltext	Some countries have a closing time for restaurants and events. Operations must cease at this time. You can apply for the closing time to be shortened. The legal requirements vary from country to country.
Erforderliche Unterlagen	Informal justification in text form about the existence of a public need.
Voraussetzungen	The existence of a public need must be demonstrated.

Verfahrensablauf	If you want to apply for a shortening of the curfew period, then • submit an application for a shortening of the curfew online or in writing to the competent authority as early as possible. • Explain in detail why you see a "public need" to shorten the closing time. This is often justified by the event that you want to continue. • You will receive a permit or a decision rejecting the application.

Bearbeitungsdauer	Processing usually takes one to two weeks.
Frist	A deadline is not specified by law. However, it is advisable to apply for a reduction in the blocking period at an early stage.
