Teaser

For the construction and operation of warehouses in which explosive substances are to be stored or for significant changes to these warehouses, you require a permit in accordance with the Explosives Act.

Volltext

Explosive substances have a high hazard potential. The aim of the Explosives Act (SprengG) is to protect people and property from these dangers.

Against this background, you generally need a storage permit in accordance with the Explosives Act for the storage of explosive substances. Substantial changes to an approved warehouse or significant changes to operation are also subject to approval. From the storage of a net explosion mass of 10 tonnes, you need a permit in accordance with § 4 of the Federal Immission Control Act (BImSchG). The permit according to BImSchG is then also valid as a permit according to the Explosives Act.

A storage permit may be omitted if the "small quantities" specified in the Second Ordinance to the Explosives Act (2nd SprengV) are not exceeded.

- Information on the type and quantity of explosive substances (BAM group, storage group, compatibility group)
- Building description, construction documents, construction method
- If applicable, copy of the permit according to §7 or § 27 SprengG for handling explosive substances
- Type approval, if applicable
- If necessary, concept for the prevention of incidents with safety management
- If applicable, fire protection concept according to industrial building directive with floor plan and location of the safety-related equipment (such as extinguishing equipment)
- if applicable, expert opinions at the request of the authority

Voraussetzungen

As an operator, you must be in possession of a valid permit to purchase and handle explosive substances

The application documents must comply with the State Ordinance on Construction Documents and Construction Testing (BauuntPrüfVO) and be prepared by a person entitled to submit plans (e.g. architect).

Verfahrensablauf

- Since this is a complex procedure, it is recommended to contact the responsible clerk before submitting an application.
- Submission of an application and annexes to the competent authority.
- Checking the application for completeness and plausibility and, if necessary, requesting missing documents.
- Usually arranging an on-site appointment.
- On-site inspection and, if necessary, request for further documents.
- Notification of the decision and request for payment.
