Volltext	<p>After your successful training at a state-recognized training center for psychotherapy, you can be granted a license to practice as a psychological psychotherapist provided that the other legal requirements are met. Once your license has been granted, you are entitled to, the profession of psychological psychotherapist in Germany independently and on your own responsibility.</p> <p>The license to practice is granted for an unlimited period and is valid for the entire Federal Republic of Germany.</p>

## Sachverhalt

- tabular curriculum vitae
- Extract from the Federal Central Register, dissued no earlier than one month prior to submission (document type O)
- Certificate of the state examination for psychological psychotherapists Declaration as to whether the applicant is subject to criminal proceedings before a court or a public prosecutor's investigation
- Medical certificate, which must not be older than one month, stating that the applicant is is not unfit in terms of health to exercise the profession

## Voraussetzungen

The license to practice as a Psychological Psychotherapist is granted upon application if you:

- have completed the prescribed training and passed the state examinationpassed the state examination,
- have not been guilty of any conduct which indicates that you are unworthy or unreliable to practise the profession
- are not unfit in terms of health to practise the profession,
- have the necessary knowledge of the German language to exercise the profession.

## Kosten

Is based on the respective administrative fee schedule of the federal state or on the fee statutes of the authorities responsible under federal state law.

## Verfahrensablauf

You can apply for a license to practice at the competent state authority.

- You submit the application for licensure, including all required documents, to the competent authority
- The competent licensing authority will check the completeness of the documents submitted and
