Volltext	The license may be waived by written declaration to the competent authority. A waiver that is declared subject to a condition is invalid.
Erforderliche Unterlagen	Written waiver • License to practice medicine (original) • The date must not be in the past. A retroactive waiver is not possible. • Written declaration of renunciation with the exact date on which the renunciation of the license to practice medicine is to take effect
Voraussetzungen	There are no prerequisites for this administrative service.
Kosten	Is based on the respective administrative fee schedule of the federal state or on the fee statutes of the authorities responsible under federal state law. There are no fees.
Verfahrensablauf	You submit your written waiver to the responsible office The original license to practice medicine will be kept at the State Office for Social Affairs, Youth and Care and will not be returned to you.

	the competent authority will process it promptly. The processing time varies between the competent licensing authorities of the federal states. The processing time is usually up to two working weeks.
