| Verfahrensablauf | You remove all liquids from your baggage without being asked and present them for the aviation security check. The security staff will check liquids, liquid medicines and special liquid foodstuffs using a special inspection technique. If the harmlessness of a liquid cannot be established beyond doubt, you may not take this liquid with you in your hand baggage. |
| Bearbeitungsdauer | The check takes place at the general aviation security check. |

| Hinweise | Liquids over 100 ml that are not medicines, special food or duty-free purchases may not be transported in your hand baggage.
