Volltext	If, after the hunting licence has been issued, there have been changes to the area on which you are entitled to hunt, you must have them entered in your hunting licence. The registration must be carried out by the authority responsible for your place of residence.

Kosten	The fee for issuing or renewing the hunting licence is subject to a hunting tax of five times the amount of the fee.
