Volltext	<p>On March 29, 2017, the United Kingdom of Great Britain and Northern Ireland (UK) formally announced its intention to leave the European Union (EU).</p> <p>The withdrawal agreement negotiated between the negotiating parties to regulate this "Brexit", which would mitigate the withdrawal and also provide for a longer transition period, has not yet found a majority in the British House of Commons.
