Teaser	Do they extract water from an above-ground water or groundwater, or do they extract or discharge groundwater? In this case, a fee must be paid to the respective federal state.
Volltext	In Germany, a water abstraction fee may be charged for the abstraction and discharge of water from an above-ground water, as well as for the extraction, transport of substation, substation and discharge of groundwater. The individual countries decide whether and to what extent the collection of water collection fees takes place.
Erforderliche Unterlagen	There is no uniform regulation in the Länder where water abstraction charges are levied.
Voraussetzungen	Water abstraction is subject to a charge for those who take water from an above-ground body of water, discharge it or extract groundwater, extract it, unearth or discharge it.
Kosten	The amount of the fee depends in principle on the medium from which the water was taken (groundwater or above-ground water), the amount of water and the rate of charge to be used.
Verfahrensablauf	There is no uniform procedure of the Länder, as this depends on the specific legal requirements and
