Teaser	As a person subject to registration, you must notify the registration authority of any change of main residence within two weeks.
Volltext	If you have several residences in Germany and the status of your residence has changed (main residence is now used as a secondary residence or secondary residence is now used as main residence without moving into or out of a new or previous residence), you are obliged to inform the competent registration authority of this.
	<ul> <li>If you are married or living in a civil partnership: the home primarily used by the family or civil partnership. This also applies if you are only temporarily separated from your family or partner.</li> <li>If you are married or in a civil partnership and live apart permanently: Your predominantly used home.</li> <li>If you are a minor: the home mainly used by your parents or foster parents. If they live separately, the main residence is the home in which you mainly live.</li> <li>Only if the predominantly used home cannot be determined beyond doubt should the focus of the living relationships be taken into account. Indications for this are, for example, the type of home, personal ties, social and local political activities as well as membership in clubs and other organizations.</li> </ul>

	A secondary residence is any other residence in Germany. You can therefore have one main residence and several secondary residences.
Erforderliche Unterlagen	Please bring an identity document (e.g. identity card or passport as proof of identity and to change the apartment details).
Voraussetzungen	You have several homes in Germany.
	You use your previous main residence as a secondary residence or your previous secondary residence as your main residence.
Kosten	none
Verfahrensablauf	You must appear in person at the relevant registration office.
Bearbeitungsdauer	none (the change of status is entered directly into the register of residents at the registration office)
Frist	You are obliged to inform the relevant registration authority of the change of status of your home within two weeks. The deadline begins on the day on which the change of residence took place.

Kurztext	<ul> <li>Change in the status of the residence</li> <li>Any change to the main residence (for example, the previous secondary residence is used as the main residence and the previous main residence is now used as a secondary residence) must be reported to the relevant registration authority.</li> <li>The registration authority for the new main residence is responsible.</li> </ul>
