Teaser	As an employer, you can eliminate the need for recurring inspections of certain systems in potentially explosive atmospheres by drawing up a maintenance concept.
Volltext	Periodic inspections of certain systems or components of systems in potentially explosive atmospheres may not be required if the employer has defined a maintenance concept as part of the risk assessment. This must ensure that a safe condition of the system is maintained and that explosion safety is guaranteed. The suitability of the maintenance concept must be assessed as part of the inspection. The work and measures carried out on the system as part of the maintenance concept must be documented and presented to the authorities on request.

Erforderliche Unterlagen	An informal complaint can be made by telephone, e-mail or in writing. The following information is required for processing: • Type of installation(s) requiring monitoring • Details of the employer/operator • Details of the reason for the complaint
Voraussetzungen	For certain systems in potentially explosive atmospheres, a maintenance concept that meets certain requirements may make a periodic inspection unnecessary.
Kosten	Gebühr: 50€ - 300€ depending on expenditure Fees and expenses are incurred. Depending on the cost, this can be between 50.00 and 320.00 euros.
Verfahrensablauf	Receipt of the complaint (online or informally in another form) Not online: Follow-up action by the authority 1. Request for maintenance concept 2. Inspection 3. Inspection notice to employer, possibly with additional requirements and deadline
