Voraussetzungen	<p>The property should be protected as a cultural monument in accordance with the Monument Protection Act.</p> <p>For this purpose, the current list of monuments can be called up and viewed as a publicly accessible list of monuments on the homepage of the Directorate for the Preservation of Monuments.</p> <p>The list of monuments is the list of all cultural monuments in the state.</p> <p>It contains only brief information.</p> <p>The list is constantly updated and supplemented with newly recorded monuments.</p>

Verfahrensablauf	<ul style="list-style-type: none"> <li>Receipt of a request by the Inventory Office with a request for information on the monument status and the scope of protection by phone call, e-mail or letter <ul style="list-style-type: none"> <li>Checking the address data, if necessary further research in the geoportal</li> <li>Research in the monument database</li> <li>File research on the requested object</li> <li>Research documents from the list of monuments in paper form</li> <li>Possibly information from corresponding monument topography</li> <li>Researching the digital map from the data set and supplement to the inspection case (if available)</li> <li>Answering the inquiry based on the results or</li> <li>in the case of complex and technical questions, forwarding to the responsible scientific processor or the head of department</li> </ul> </li> </ul>
