- The application must be made in writing.
- When setting up in restaurants, the operator of the restaurant must have a restaurant license.

- In the event of a change of a restaurant operator, a new application for the place of installation must be submitted.

## Kurztext

- In order to be allowed to set up gaming devices that offer a possibility of winning, the suitability of the place of installation must be determined.
- Pursuant to Section 33c of the German Trade, Commerce and Industry Regulation Act (Gewerbeordnung), proof must be provided for each location where gambling devices with the possibility of winning are set up that it is suitable for this purpose. Such a confirmation of suitability by the locally competent authority is a prerequisite for the installation of gaming machines with the possibility of winning.
- Pursuant to Section 1 of the Gaming Ordinance, gambling devices with the possibility of winning may only be set up on the premises of pubs and restaurants where drinks and food can be consumed on the spot, accommodation establishments, gaming arcades and similar establishments, as well as betting offices of licensed bookmakers.
