Modul**Sachverhalt**

- The claim exists for both women and men.
- Sterilization required by illness is present when treatment is necessary to protect personal health. This is the case, for example, in women for whose pregnancy would be harmful to health and for which another form of contraception is not possible or reliable.
- On the other hand, there is no medical indication if, due to the state of health of a parent in the event of pregnancy, a disease of the child would be to be feared, since in this case sterilization is not a curative, but a prophylactic measure.
- Sterilizations that are not due to illness and are to be carried out within the framework of individual life planning cannot be carried out at the expense of the GKV.
